NARRATIVE

Narrative

On 12-11-13, Deputy Vaile was on patrol in Lehigh Acres of Lee County Florida. At approximately 0735 hours, Deputy Vaile was dispatched to the area of 1919 Roosavelt Ave. by a canal concerning a suspicious person, later identified as Dennis Culver III DOB 5-3-80. Dennis was seen walking near the outside perimeter of an active homicide crime scene.

Upon arrival, contact was made with Dennis who identified himself as working for the News Press. Dennis was advised that it wasn't a good idea to be in the area that he was in and that he should go back to where the rest of the media was staged. Dennis apologized and walked back to the media staging area.

While Deputy Vaile was completing a Field Interview Card for what had transpired, it was discovered that Dennis had a suspended / canceled driver's license for the following reasons - 1) REFUSE SUBMIT BREATH/URINE/BLOOD TEST OFFENSE DATE: 01-01-13 OFFENSE COUNTY: FLAGLER PERMIT ISSUED/LICENSE RECEIVED NOTICE REQUIRED BY S.322.251 GIVEN 01/17/13.

2) FAILURE TO COMPLETE BDI 3208/26/13 NOTICE REQUIRED BY S.322.251 GIVEN 08/26/13.

3) FR SUSP PIP CANCELLATION 724762408 NOTICE REQUIRED BY S.322.251 GIVEN 04/19/13.

4) DL EXPIRED-F.S. 322.08 (6)09/26/13 NOTICE REQUIRED BY S.322.251 GIVEN 09/26/13.

5) FAILED TO PAY TRAFFIC FINE(PENALTY) NOTICE REQUIRED BY S.322.251 GIVEN 07/01/13.

Deputy Vaile advised Dennis that his DL was suspended for the mentioned reasons and told that he couldn't drive or he could go to jail. Dennis advised that he didn't know that he had a suspended DL. Deputy Vaile asked Dennis if he drove to the scene to which he replied that he did. Dennis told Deputy Vaile that he would have a friend pick up his vehicle (dark Ford F-150 tag# BKZD85) or have it towed.

At approximately 0823 hours, Deputy Vaile received information that Dennis' vehicle was seen driving away from the media staging area towards Joel Blvd. Deputy Vaile was in the area and observed Dennis' vehicle traveling south bound on Joel Blvd. towards E. 15th St., turning west bound onto E. 15th St. Dennis' vehicle then turned north bound onto Michael Ave. before it pulled over to the side of the road.

As Deputy Vaile slowly drove behind Dennis' vehicle to park on the road, Dennis stepped out of the driver side door and approached Deputy Vaile's vehicle. Deputy Vaile activated his overhead lights to initiate a traffic stop.

When Deputy Vaile made contact with Dennis, Dennis advised that he was just on his way to his home to drop off his vehicle. Deputy Vaile again told Dennis that he wasn't supposed to be driving. Dennis replied that he knew that he wasn't supposed to drive but he was only going to go home and park his truck. Dennis stated that he didn't want to go to jail because he might get fired.

Deputy Vaile confirmed the suspension / cancellation information for Dennis' DL via Lee County Wants and Warrants channel. Dennis was then placed into custody for violation of F.S.S. 322.34 (2)(A). Dennis' license plate was seized and placed into evidence as per Wants and Warrants. Dennis was issued UTC# A1T3E4E for knowingly driving on a suspended / canceled DL and warning# 0105875DP. Dennis was transported to the Lee County Jail.
